We are pleased to inform our members that in collaboration with "Bank of Maharashtra", we will be conducting a 5-Day Orientation Workshop (Non - Residential) on "Foreign Trade and Foreign Exchange Business" under Knowledge Initiative Series 2026 at their Staff Training College, Pashan, Pune from 5th October 2026 to 9th October 2026. BACKGROUND

With the ongoing process of liberalisation of policies governing Foreign Exchange transactions and other changes taking place in the areas of international trade there are host of opportunities for Authorized Dealer banks to develop their foreign trade / exchange business. It is therefore, essential that the officers assigned to the Trade and Forex business vertical possess necessary knowledge to guide their customers. Front line staff needs to develop skills not just to tap the available business opportunities but also to ensure compliance with the regulatory guidelines and manage the risks effectively.

OBJECTIVE:

To impart knowledge in foreign trade / foreign exchange business and to improve operational skill sets of officers in handling FX transactions. Participation in the workshop conducted by FEDAI will also enable officers of member banks to share best business practices and network with each other for development of knowledge and skills.

TARGET GROUP:

- Junior and Middle level officials from member banks presently working in 'B' category branches and FX /Trade processing centres responsible for handling and development of foreign trade / exchange business. Similarly, the Officials to be assigned in these business roles in near future.
- Officials from inspection / audit department assigned with Forex/Trade Audits.
- Officers responsible for credit/trade finance underwriting / forex portfolios and credit monitoring teams.
